

Where would you 'tred' for cash?

#### HOW TO ENTER

Grab your entry form from your new treds packaging or print from the website [www.adeptgear.com](http://www.adeptgear.com) Purchase any pair of adept 'treds' from one of our stockists or the website between 20/10/05 and 05/01/06; Complete the entry form by writing in 25 words or less, 'Where would you 'tred' for cash?' . Attach the Adept treds barcode from your purchase and post to:

#### Conditions of Entry

1. Information regarding prizes and how to enter forms part of these conditions. By entering, entrants accept these conditions.
2. Entry is open to all Australian residents other than employees and their immediate families of the Promoter, the Promoter's agencies and companies associated with this promotion ("Eligible Entrant").
3. Competition commences 20/10/05 and closes last mail received 05/01/06 ("Competition Period").
4. To enter, consumers must purchase Adept Treds from any Surf store or online (between 20/10/05 and 05/01/06, fully complete the entry form found in your treds packaging or on the [www.adeptgear.com](http://www.adeptgear.com) website, including by answering the following question in 25 words or less: "Where would you tred for \$1000?" and send the completed entry form together with the original barcode from the Treds purchased: ADEPT - Where would you tred? 5. Consumers may enter this competition as many times as they like provided that each entry is based on a separate purchase, is sent in a separate envelope enclosing an original barcode from the Participating Product purchased, and a separate original completed entry form.
